Reading Parts Narrator, Carlos, Louise, Jenny, Mrs. Evans

NARRATOR The scene is a sixth grade classroom. The date is April 1, 1996.


LOUISE It is a disgrace! We ought to write the President.

CARLOS Well, somebody should do something. That bell belongs to all the people. How could it be sold? It's a national treasure, even if it did get a crack in it when it was rung in 1776.

WRITER ONE Tell when the bell was first hung in Independence Hall steeple. What happened to it the first time it was rung?

WRITER TWO What is The Declaration of Independence? Who was the man who read it aloud for the first time on July 8, 1776?

LOUISE That's right. And a year later when the British entered Philadelphia it was taken down and hidden so they wouldn't melt it down and use it for cannon.

JENNY Wow, I don't see how they could hide something that big.

WRITER THREE How much did the Liberty Bell weigh when it was cast?

LOUISE They hid it in the floorboards in a church in Allentown. That kept the British from getting their hands on it.
